7 Any Other Business

- 7.1 .1 Edward Hutchison advised that he has some **books to donate** either to MERL Library or to FOLAR to sell.
 - .2 Helen Neve agreed to advise Edward on the procedure for donation, which would involve initially listing the books.
- 7.2 .1 Richard Tranter advised that quite a few bids for funding had been submitted to the Research Council which proposed to use the archive at MERL, which was raising awareness of the archive with other researchers and could generate a snowball effect on interest in using the archive for research.
 - .2 Annabel advised that FOLAR were included in 4 university groups who were bidding for funding, and Richard confirmed that there were many others that did not include FOLAR.
- 7.3 .1 Virginia Hinze said the Gardens Trust series of **talks on Post-war Designed Landscapes** had been extremely popular with huge audiences (200-250 people) and had raised the profile of archives including the MERL archive. She advised that they were considering another series on the same subject but with a different focus and would be in contact with FOLAR to collaborate.
 - .2 Annabel advised that a FOLAR were planning a series on talks involving a talk on each of the post-war landscape projects registered/listed in 2020, particularly the ones archived at MERL, with a focus on people as well as place and would be in contact with the Gardens Trust to collaborate and avoid duplication.
- 7.4 .1 David Appleton said that many of the LI members didn't know anything about the archive and particularly what it contained. He asked whether the archive could be viewed at MERL, whether there was a catalogue and that such information should be made easily available to all members.
 - .2 Annabel Downs advised that FOLAR were working to **raise the profile of the archive** at MERL and that the archives could normally be viewed at MERL, but covid restrictions had closed physical access. She also advised that the FOLAR communications team and MERL were working on an induction to the archive. Karen Fitzsimon advised that there were catalogues of the various landscape archives at MERL https://www.reading.ac.uk/merl/collections/Archives A to Z/merl-SR Ll.aspx Annabel advised that MERL had recently set up a virtual reading room and had requested feedback from FOLAR. It includes some photos and drawings from some of the landscape collections. Annabel agreed to email David with the information, and anyone else who would like it.
 - .3 Edward Hutchison advised that the proposed article on the importance of archives and the LI archive at MERL by FOLAR in Landscape Matters magazine in Autumn 2021 and the subsequent debate would raise the profile of the archive with a significant number of LI members
 - .4 Annabel advised that it was also necessary to raise the awareness of practices to the importance of keeping archive material rather than binning it.

- 7.5 .1 Annabel asked Barbara Simms to **keep FOLAR advised of any relevant research** using the MERL landscape archive being undertaken at the moment. Barbara advised that the only one at the moment concerns Russell Page which is mostly using the Garden Museum archive.

Chair's Report

FOLAR is a friends group of landscape architects and other interested parties tasked with supporting and advising The MERL (University of Reading), on behalf of the LI, with regard to maintaining and developing the archive and library.

FOLAR was established to support the Landscape Institute in the delivery of its charitable objects: 'to protect, conserve and enhance the natural and built environment for the benefit of the public by promoting the arts and sciences of Landscape Architecture...and for that purpose to foster and encourage the dissemination of knowledge relating to Landscape Architecture and the promotion of research and education therein...'

This report outlines FOLAR's activities since October 2020, and our plans and aspirations for the next 12 months from May 2021. Our previous AGM was October 2020 on zoom. Our future AGMs will be held annually in April/May.

Since October 2020 FOLAR has continued to be proactive promoting the landscape archive and landscape architecture to new audiences. Fortunately like some other organisations FOLAR has adopted new ways of doing this following the COVID lockdown and we have achieved more talks, more regular committee meetings, and meetings with MERL than previously. Operating online has also brought us in touch with a wider and more dispersed audience.

Oct 2020 - May 2021

Continuing Promotion of the LI Archive

OCT 2020 AGM + FOLAR and LI NE *Speaking out for landscape – Oral history and landscape architecture* - talks by Marie Lagerwall discussing her research findings re FOLAR 2019 Review of Landscape Oral Histories; Sally Watson on researching Erskine's archive with regard to children's plays paces at Byker Wall, Newcastle; Colin Moore on the Telling Stories initiative. Including Helen Neve's introduction, the three talks are freely available on FOLAR website https://www.folar.uk/events

MARCH 2021 *From the contemporary archive series* – with talks by Richard Cass on being creative and inventive with post-industrial landscapes; Mark Loxton on master planning a 1980s new town in Hong Kong; Guy Denton on uplifting local spaces in urban centres in middle England; and Jun Huang on interdisciplinary approach in design. These four talks are freely available on FOLAR website https://www.folar.uk/events

MAY 2021 *Women in Landscape* architecture – we are repeating the first series so that we can record them this time and adding a fourth talk: Dr Phil Back on Elisabeth Beazley; and Sally Ingram on Susan Jellicoe; Hal Moggridge on Brenda Colvin; and Diana Armstrong Bell on her own work. These will be made freely available on FOLAR website.

We have extended the FOLAR **blog** series with an insight on **Burle Marx** and part one of an account how the **Huddart drawings came to MERL**

We have received from John Peverley six *letters from Geoffrey Collens* studying landscape architecture at Penn, and early days at Derek Lovejoy's office; three have been transcribed, the second batch will be posted on people places projects shortly. (The original letters and the Burle Marx drawings have been sent to the LI archive at MERL)

Some FOLARs were invited to contribute to a successful series of talks in association with Gardens Trust on the different categories of **20c post-war Listed Landscapes** in Feb 2021 and have been in discussions since about how to expand this initiative to a wider audience and how to get more post war landscapes listed.

FOLAR has held and is in ongoing discussion with LI chair and trustees to secure a **proportionate donation to MERL for the upkeep and development of LI archive** there, in accordance with the promise made by the LI trustees to the membership in advance of the 2013 LI EGM.

Continuing Promotion of Landscape Research

FOLAR invited as project partner to AHRC **Landscapes of Post War Infrastructure** - Luca Csepely-Knorr and Richard Brook, Manchester Metropolitan University; events on Zoom during COVID, ongoing from 2019

FOLAR invited as partner to proposed AHRC project **Women of the Welfare Landscape**, Brenda Colvin 100 anniversary and travelling exhibition Luca Csepely-Knorr and Richard Brook, Manchester Metropolitan University, 2021

FOLAR contributing to proposed AHRC research bid by multi-disciplinary group now led by Sarah Spooner UEA Wellbeing and modern landscape design: unlocking knowledge from the Landscape Institute archive; 2019 bid due to be submitted May 2021

FOLAR contributing to NERC project bid led by Jan Woudstra and Camilla Allen Uni of Sheffield **The Equitable City of Trees: Re-visioning urban and peri-urban Treescapes**; bid to be resubmitted in May 2021

FOLAR continues to provide information for PhD students in landscape research and we are extremely encouraged (and excited!) by the topics being covered, and the growing numbers of students.

We have to more detailed life stories to prepare on **Michael Littlewood** and **Laurie Fricker** following their sad demise – if anyone has any info they would like to share with us please do get in touch

FOLAR has very recently joined the Network of European Landscape Architecture Archives, and we look forward to exploring this new collaboration.

Treasurer's Report

It is a pleasure to report that FOLAR's finances remain in a healthy condition despite, and in some cases because of, Covid 19 restrictions.

Last year I reported that our accounts showed a significantly different financial pattern from the preceding year and, due to the Corona virus, the pattern is, once again, very different for the year 2020/21. The year started and finished in lockdown and, in common with many organisations, Zoom meetings and online events have quickly became the norm. Our income has been low, but our expenditure even lower, leaving the bank balance showing a modest increase. I would also suggest that our outreach and promotion of the archive, based on a simple assessment of activity, event attendance and membership, has improved significantly.

The headline figures are as follows:

In detail, I would like to mention the following items which have direct relevance to our financial situation.

Website: the website has now been in operation for 15 months and is proving a valuable tool. Its role in raising FOLAR's profile and providing a platform for collecting new archive material has been unexpectedly positive. Financially, it has also proved to be a good investment, in particular by providing options for on line membership renewals. Although the provider, Stripe, takes a cut from every transaction, ease of use and provision of credit card options have been beneficial in maintaining and increasing membership.

Events: as noted in the Chair's report, operating on-line events via Zoom, has increased attendance significantly. Our ticket prices have been modest, but the offer of free tickets to members has increased membership income considerably.

Oral History: for obvious reasons, the Oral History project has had to be put on hold, but during the year, we used our LI grant funding to purchase two sets of recording equipment and have carried out training in how to operate the technology.

Book sales: thanks to Helen Brown, it has been a very good year for book sales, raising over £400 for FOLAR funds. Our second hand book catalogue continues to expand and we hope to recommence sales once Covid restrictions allow us to transfer the unsold books to Berkshire. Thanks to Bettina Kirkham for taking over the role of book seller.

Financial Year 2021/22: obviously it is very difficult to predict the outcomes for the new financial year, but I think we can be fairly optimistic, based on performance achieved in 2020/21. We hope the 2021 annual symposium, postponed to November 2021, will be a traditional live event, perhaps with an online component, but alternative options are feasible if restrictions continue.

And finally - please renew your memberships and encourage others to join as well. We propose to continue the same membership rates for 2021/22, ie £20 for individual members, £50 for practice members, and free to students. Additionally Zoom event rates will continue as free for members and £5 for non-members. The Symposium, if live, will probably be similar to last year, ie £30 for members and £40 for non-members; this will be confirmed in due course.

In conclusion I am still of the opinion that FOLAR offers good value for money and that our finances will be sufficient to continue a diverse programme of activities throughout the current financial year.
